### More PPP Loan Funds Available For Small Businesses

There is additional money available from the Small Business Administration for a new round

of Paycheck Protection Program (PPP) loans courtesy of the Emergency Coronavirus Relief Act of 2020.

Here's what you need to know:

# Requirements to Take Out a 2nd PPP Loan.

If you received PPP loan proceeds in 2020, and wish to apply for a 2nd PPP loan, here are the qualifications:

- Your business must have 300 or fewer employees.
- Demonstrate a decrease in gross receipts of at least 25 percent in any quarter of 2020 compared to the same quarter in 2019.
- Have used or will soon use the entire amount of their first PPP loan.

Requirements to Take Out an Initial PPP Loan.

If you didn't take out a PPP loan in 2020, but wish to do so now, you can still apply for a PPP loan.

For an initial PPP loan, your business must have been open on or before February 15, 2020 and have 500 or fewer employees or independent contractors for

whom the business paid salaries, compensation, and payroll taxes.

### Loan Forgiveness for the New PPP Loans.

As with the first round of PPP loans, the new loans are eligible to be entirely forgiven if certain requirements are met. There is even a simplified application for forgiveness if the loan amount is less than \$150,000. The maximum amount of a new round of PPP funding is \$2 million.

### How To Budget Money

If I have take-home pay of, say, \$2,000 a month, how can I pay for housing, food, insurance, health care, debt repayment, and fun without running out of money? That's a lot to cover with a limited amount, and this is a zero-sum game.

The answer is to make a budget.

- Calculate your monthly income, pick a budgeting method, and monitor your progress.
- $\bullet$  There are different ways to go about creating a budget. If you haven't tried the 50/30/20 rule give it a try. Allow up to 50% of your income for needs. Leave 30% of your income for wants. Commit 20% of your income to savings and debt repayment.

### Franchises: Investigate Before You Invest In Franchises

Of the thousands of new businesses created every day in the United States, many are franchise outlets. If you've ever thought about buying a franchise, here are some facts worth considering.

A franchise gives the buyer the right to use a trademarked name in selling a product or service. The purchase of a franchise includes training,

location assistance, inventory to get started, and advertising support. In addition, most franchises have a proven business model and a record of success.

There are costs connected with buying a franchise beyond the usual business expenses of payroll, rent, etc.

**First**, you must pay an initial franchise fee which can range from thousands to hundreds of thousands of dollars.

**Second,** you must also pay an ongoing royalty to the franchiser, which is typically a certain percent of sales.

**Third,** there are often separate payments and fees required to pay for advertising campaigns and administrative projects.

To research a franchise opportunity, start by looking over its Uniform Franchise Offering Circular. Details to review in addition to fees are territory size, training offered, competition, franchisee turnover, and termination rights. Next, interview as many current franchise operators as possible. Are they profitable? How long did it take to become profitable? Are they satisfied with the support they receive from the franchiser?

Finally, ask yourself some crucial questions. Are you really interested in the franchised product or service? Will you be able to devote the necessary time to the business? Do you have the financial resources to get the business up and running? Are the franchise name, training, and support worth the fees? If your answers are positive, you may have found the right route for starting your own business.

### **Dealing With Stress**

Stress is a reaction to a situation where a person feels threatened or anxious. Learning healthy ways to cope and getting the right care and support can help reduce stressful feelings and symptoms.

- Difficulty concentrating and making decisions.
- Headaches, back pains, and stomach problems.
- Smoking or use of alcohol or drugs.

Feeling emotional and nervous or having trouble sleeping and eating can all be normal reactions to stress. Here are some healthy ways you can deal with stress:

- **Take care of yourself.** Eat healthy, exercise, get plenty of sleep, and give yourself a break if you feel stressed out.
- **Talk to others.** Share your problems and how you are feeling and coping with a parent, friend, counselor, doctor, or pastor.
- **Avoid drugs and alcohol.** These may seem to help, but they can create additional problems and increase the stress you are already feeling.
- **Take a break**. If news events are causing your stress, take a break from listening or watching the news.
- Recognize when you need more help. If problems continue or you are thinking about suicide, talk to a psychologist, social worker, or professional counselor.

### **2021 Tax Filing Season Begins Feb. 12**

he Internal Revenue Service announced that the nation's tax season will start on Friday, February 12, 2021, when the tax agency will

begin accepting and processing 2020 tax year returns.

The February 12 start date for individual tax return filers allows the IRS time to do additional programming and testing of IRS systems following the December 27 tax law changes that provided a second round of Economic Impact Payments and other benefits.

This programming work is critical to ensuring IRS systems run smoothly. If filing season were opened without the correct programming in place, then there could be a delay in issuing refunds to taxpayers. These changes ensure that eligible people will receive any remaining stimulus money as a Recovery Rebate Credit when they file their 2020 tax return.

To speed refunds during the pandemic, the IRS urges taxpayers to file electronically with direct deposit as soon as they have the information they need. People can begin filing their tax returns immediately with tax software companies, including IRS Free File partners. These groups are starting to accept tax returns now, and the returns will be transmitted to the IRS starting February 12.

- Facebook May Be Peaking. Really. Facebook is no longer the kingpin in the social media world. According to Forbes, 41% of its users are over the age of 65. ### Statement Recently?

You can get your personal Social Security Statement online by using your "my Social Security" account. If you don't yet have an account, you can easily create one. Your online Statement gives you secure and convenient access to your earnings records. It also shows estimates for retirement, disability, and survivors benefits you and your family may be eligible for.

Social Security will also mail paper statements to workers age 60 and older three months before their birthday if they don't receive Social Security benefits and don't yet have a my Social Security account.
